WARNING TO OWNER

- In addition to a Tree Removal Permit, other permit requirements may apply, such as protection of threatened or endangered species and wetland protection.
- Call Sunshine811 – For digging projects large and small, Chapter 556, F.S. says you must notify Sunshine 811 by calling 811. The process takes two full business days - day one starts the day after you call. This is a free service.
- For construction valued over \$2,500.00, your failure to record a Notice of Commencement may result in your paying twice for improvements to your property. If you intend to obtain financing, consult with your lender or an attorney before recording a Notice of Commencement.
- In addition to the requirements of this permit, there may be additional restrictions applicable to this property that may be found in the public records of the County.
- This permit becomes null and void if construction is not commenced within six months of issuance and an inspection is not requested within the six month period.
